

## 2012 Union Beach Dog License Application

Please stop by our office from 9 a.m. to 12:30 p.m. and 1:30 p.m. to 4:30 p.m., Monday through Friday. The Board of Health will also be open Saturdays in January – the 7<sup>th</sup>, 14<sup>th</sup>, 21<sup>st</sup> and 28 – from 9 a.m. to noon. Please call 732-264-2365 for more information, or email us at [ubboardofhealth@optonline.net](mailto:ubboardofhealth@optonline.net). If you would like us to mail your tags to you, you must supply us with the dog information form (see below), up-to-date rabies certificate, and a self-addressed stamped envelope, along with your payment. A secure box is located in Police Headquarters Hallway to drop off information at your convenience.

Before obtaining a 2012 dog license, rabies vaccination must be current and may not expire during the license year. There are free rabies clinics on January 19, 2012 at the Firehouse on Broad Street in Eatontown from 7 p.m. to 8 p.m. and on January 28, 2012 at the Department of Public Works in Howell on Preventorium Road from 9 a.m. to noon.

Please be aware of the following Borough Ordinances, Policies, and Laws regarding dogs and our community:

- Our Borough Ordinance requires that all dogs seven (7) months or older, or having a permanent set of teeth, must be licensed and have a current tag affixed to his or her collar or harness.
- No more than three (3) dogs of licensing age may be kept, maintained, or harbored at any one time at any residential housing unit.
- Dogs are not permitted to run at large. Owners are subject to a fine.
- Borough Ordinance requires that dog feces be removed immediately and disposed of in a sanitary manner.
- Dogs, with the exception of service animals, are not permitted on the beach or beachfront walkway.

- Dogs must be licensed within ten (10) days of the licensing age.
- Newly acquired dogs must be licensed within ten (10) days of acquisition.
- Dogs currently licensed in another state or town must be re-licensed in Union Beach within ninety (90) days.
- A Union Beach license will be issued, free of charge, to dogs currently licensed in another New Jersey town.
- There is no charge for licensing Seeing Eye, Hearing Ear, or Service dogs for the handicapped.
- Dog licenses will only be issued in the name of an adult member of the household.
- All dog licenses will expire January 31 of each year.
- Check rabies vaccine information and spay/neuter status. If there have been any changes since last registration, be sure to enclose a copy of the veterinarian certificates. Rabies vaccinations must be current and may not expire during the licensing year. Spayed and neutered dogs qualify for a reduced licensing fee. If you have not already qualified for the reduced fee, you may do so by enclosing a spay/neuter certificate signed by a licensed veterinarian.

- Be sure to enclose copies (not originals, as they cannot be returned) of rabies certificates and spay/neuter certificates where applicable.
